1. Name of the Society: The name of Society shall be "Namo Raghway Educational Welfare Society"
2. Registered Office: The registered office of the society shall be Situated at Radhiya, Rai Tola, and P.O. Radhiya, P.S. Govindganj, Disst. East Champaran, Bihar, PIN-845458. The Registered office may be changed at any Time by the society and will be initiated to I.G. Registration Bihar within 15 days from Such change.
3. Area of Operation: The area of operation will be all over India.

4. Aim and Objective:

(A) The society will work for development of rural area people of all communities without any discrimination on the basis of caste, creed or sex in the field of education, health, awareness, sanitation, cultural development and problem of unemployment and to stop migration due to non availability of quality education in rural areas.

(B) To run educational institute for children and women at Primary, Secondary and Higher secondary level and to achieve this goal boys and girls schools and colleges shall be setup.

(C) To run educational development program of patriotism and environment and manage, maintain and run educational institutions both technical and non-technical institutions and to run development program as well as welfare program for mentally and physically challenged people in the society.

(D) The society shall work for various type of personality development program, spoken English program for rural people of all communities without any discrimination on the basis of caste, creed and sex in the field of education.

(E) To help the poor, helpless, orphan children and people belonging to SC, ST, OBC and General communities to provide educational facilities, sanitation facilities and safe drinking water facilities.

(F) To uplift the technical know how by dint of vocational training from different areas to technical education such as T.V. training, Computer training, Fitter, Electrician, Wireman, Electronic A.C. machines, Radio-Video training, Automobile training, Driving and training of Modern Technologies.

(G) To make Painting, Embroidery, Bangles, Bindi, Hosiery, Candle, Pickles Making, Leather Work and to run Butician Courses etc. for their economic development.

(H) To make rural masses self reliant the society shall open vocational training centre, small and cottage industries, handicraft centre and other self employment program on co-operative basis.

(I) To manage and maintain technical and non technical educational institutions Reading rooms, common rooms, libraries in the locality and provide education and educational facilities to the rural masses.

(J) To propagate, impart and adopt and audio-visual method for over all social Cultural, economic and historical awareness, solving the social problem, crime, drug abuses, child marriage and any other prevailing abuse and help in the inculcation of such behavior as would bring happiness to the family and society.

(K) To undertake complete literacy programme for poor, downtrodden, minority and needy illiterate people by adult education, vocational education and training. The Institution aims to make educate employed the (Boys And Girls) self contained under self employment programme giving training in Hindi and English Typewriting, Stenography, Electronics, Computer, Software and Hardware and proper training in refrigeration.

(L) To provide knowledge to all kind of people to eradicate AIDs, Cancer, Kalazar, T.B. Leprosy and run counseling and awareness programmes of all sort in the society.

(M) To undertake survey and assessment of air, water and other pollution, arouse mass awareness regarding environmental pollution, diffuse skills to compact this problem encourage social forestry and reclamation of vanishing natural forests.

**RULES & REGULATIONS**  
**OF**  
**"NAMO RAGHWAY EDUCATIONAL WELFARE SOCIETY"**

1. Definition:

- (A) Society means: "Namo Raghway Educational Welfare Society".
- (B) Committee means: The Managing Committee of the Society.
- (C) Office Bearer means: President, Secretary and Treasurer.
- (D) Years means: From 1<sup>st</sup> April to 31<sup>st</sup> March.
- (E) Act means: The Society Registration Act. 21, 1860.
- (F) Body means: The General Body of the Society.

2. Membership:

Membership shall be open for any male or female above the age of 18 years interested in the field of education and social welfare work who shall follow the rules and regulations of the society and who shall pay subscription of Rs. 350.00 towards membership fee annually and Rs. 3500.00 for life long.

3. Application for Admission:

A person desirous of joining the society shall apply in writing on a prescribed form along with Rs. 250.00 as admission fee to the secretary of the managing committee who shall be entitled to reject or accept the same without assigning any reason thereof.

4. Termination of Membership:

(A) If a member resigns or dies or becomes unsound of mind.

(B) If a competent court sentences a member to imprisonment for any offence involving moral turpitude.

(C) If a member is found to be engaged in activities by the managing committee which are against the interest of the society.

(D) If a member does not attend three meetings continuously without any Information to the committee.

(E) Any member in default in payment of monthly subscription for a period Exceeding three months shall automatically cease to be a member.

#### 5. Formation of Managing Committee:

(A) There shall be managing committee consisting of 7 members including of Office bearers to be elected by the annual general body meeting of the society.

(B) The members of managing committee shall hold office for a period of two years.

(C) Any casual vacancy of the committee may be filled up by the members of the managing committee for the remaining period of the office so held.

(D) The outgoing members of the committee shall be eligible for re election.

#### 6. Power and Function of the Managing committee:

(A) The managing committee shall be solely responsible for the management of all the affairs of the society and it shall have necessary power for executing decision of the general body and managing the affairs of the society in all respect.

(B) To appoint, transfer and retire the personnel of the employees.

(C) To alienate, sell, take, lease, mortgage and pledge, hypothecate, donate the property whether movable or immovable.

(D) To implement program for the execution of the objectives and allied activities of the society and to invest the fund of the society for the works of the society.

(E) To raise money by way of subscriptions donation, grants and loan etc.

- (F) To consider application for membership .
- (G) To open branch office or sub branch office in any place or places for the purpose of the society.
- (H) To make sub committee and manage all type of institutions conducted by the society.
- (I) To do all such lawful acts and things as are identical and conducive to the attainment of the object of the society.

#### 7. Power and Function of the Office Bearers:

##### (A) President

- (a) He/She will preside over all the meetings of the managing committee and the general body of the society. In the absence of the President the members present at the meeting shall elect a President from themselves and the President shall exercise all such powers.
- (b) He/She will have casting vote, Which he/she will exercise on when there is a tie in meeting.
- (c) He/She will guide, direct and supervise all the activities of the society.

##### (B) Secretary

- (a) He/She will look after day to day management of the office of the society and shall help President to discharge his/her duties.
- (b) He/She will look after any particular work if especially delegated to him/her by the management committee or the general body and shall be responsible for that work.
- (c) He/She will convened wherever necessary meeting of the society and of any committee which may be necessary to be called.
- (d) He/She will keep proper minutes of the proceeding of the meeting of the society and will do everything to give effect to the resolution passed by the general body/managing committee of the society.

(e) He/She will make all correspondence on behalf of the society and keep all records.

(f) He/She will be responsible for the proper upkeep of the accounts of the society before the general body meeting.

(g) He/She will submit annual progress reports and audited statement of the accounts of the society before the general body meeting.

(h) He/She will be at liberty to spend for the purpose of the society at any time a sum of up to Rs. 2000.00 without previous sanction of the managing committee.

(i) He/She will receive loans, grants, donation and subscription on behalf of the society.

(j) He/She will deposit the amount/cheque in the bank account of the society.

(C) Treasurer

(a) He/She will keep and maintain up to date each book like receipt book, voucher duly passed by the President/Secretary of the society.

(8) Power and Function of the General Body:

(A) The annual general body meetings of the society shall be held every year within three months of the close of the financial year.

(B) To elect office bearers and members of the managing committee.

(C) To pass the audited statement of accounts and to appoint the auditor for the ensuing year.

(D) To transact such other matter which may be brought before the meeting by the managing committee.

(9) Meetings:

(A) The managing committee may inform for transacting matters whenever they like to meet but not less than once in every three months.

(B) The emergency meeting of the managing committee may be called by the President or the Secretary by giving only 24 hours notice to the members of the committee.

(C) Special general meeting of the society may be called by the President or the Secretary by giving not less than 15 days notice in writing to the members of the committee.

(D)  $\frac{2}{3}$ <sup>rd</sup> of the valid members of the society may from the requisition of the meeting of the general body by submitting a written and signed requisition to the Secretary or the President of the society specifying the subject to be considered in such a requisitioned meeting and the President or the Secretary shall within 15 days call the general body meeting giving at least 3 days notice to the members falling which the requisition will have power to call the said meeting for taking decision in the matter for which the meeting has been requisitioned.

10. Notice:

(A) Notice of every meeting stating the general particulars of the matters to be transacted at such meeting shall be delivered or sent by post to such member.

(B) 30 clear days notice specifying the place, date, time and nature of the matter shall be given to the members by post or by hand for general body meeting.

(C) 7 days notice will be given to the members for managing committee meeting of the society.

(D) In case of emergent meeting the same can be conveyed by giving notice for 24 hours before.

11. Source of Income:

(A) Members fee and monthly subscription.

(B) By donation and subscription.

(C) By Government aid.

(D) Grant and aid from any other legal sources.

12. Quorum:

2/3<sup>rd</sup> members present and entitled to vote shall form a quorum at any meeting. If at an extraordinary meeting there is no quorum with half an hour the meeting shall stand dissolved. If however, for a General Body Meeting or managing committee meeting there is no quorum with half an hour for the time fixed the meeting shall be adjourned and no quorum will be necessary for an adjourned meeting.

13. Bank Operation:

The bank account of the society shall be maintained in the name of the society in any nationalized bank or post office by joint signature of two office bearers like President, Secretary or Treasurer.

14. Audit:

(A) The account of the society shall be audited by an auditor appointed by the general body.

(B) Inspector general of registration on his description at any time may get audited accounts of the society by any recognized chartered accountant and fee for the same shall be born by the society.

15. Inspection of Register:

All registers will be kept in the registered office and any member may inspect these registers with prior permission of the Secretary.

16. Amendments:

Any additions, alteration or omission in the objects and rules and regulations of the society shall be effect by resolution of the society by 3/5<sup>th</sup> members of the general body at a special general body meeting of the society.

17. Legal Proceedings:

The society may sue or be sued on the name of its Secretary of the society.

18. Dissolution:

- (A) The society may be dissolved by 3/5<sup>th</sup> of the member of the general body present and voting in its meeting specially conveyed for this purpose.
- (B) Before dissolution of the society the State Government consent will be obtained under section 13 of the Society Registration Act 21, 1860.
- (C) If after dissolution there remains any property moveable or immoveable after satisfaction of the all debts and liability, the property so left shall not be paid to or distributed among the members of the society but given to some other society or the Government to be determined by the votes of not less than 3/5<sup>th</sup> of the members present in person at the time of dissolution.
